- The Foundation for Music Education has selected <u>The School for the Creative and Performing Arts Middle School Band</u> as the Kentucky State winner for the 2020 Mark of Excellence National Wind Band Honors Competition. Their director is Robin Barker who is in her 36th year of teaching for Fayette County Public schools. The assistant director is Aaron Jones. The Foundation for Music Education reviews hundreds of recordings each year. Middle School and High School bands from 38 states made submissions this year.
- The Mark of Excellence project seeks to recognize and award outstanding achievement in performance by high school and middle school bands, choirs and orchestras. The project gathers entries from throughout the United States and provides valuable feedback for all entrants. A unique competitive environment is created which allows ensembles to compare their performance quality to other outstanding groups from across the country. The first awards were given in 2008. Since that time, only five Kentucky bands have been chosen to be Mark of Excellence winners. SCAPA Middle School Band is a 3 time State winner and they were National winners in 2012. Congratulations Ms. Barker, Mr. Jones and the SCAPA Middle School Band.
